General Terms and Conditions

1. **ACCEPTANCE AND REJECTION:** The City of Sparta (The City) reserves the right to reject any or all bids, to accept bids in whole or in part (unless other indicated by bidder), to waive any informalities in bids received, to accept bid on materials or equipment with variations from the specifications where efficiency of operation will not be impaired, and to award bids to best serve the interest of the City.
2. **PRICES:** Unless otherwise stated in the Bid Invitation, the following will apply: (1) prices must be F.O.B. destination specified in bid, (2) prices must be firm and not subject to escalation, (3) bid must be firm for acceptance for 30 days from bid opening date. In case of errors in extension, unit price shall govern. Discounts from bid price will not be considered in making awards.
3. **EXCEPTIONS TO SPECIFICATIONS:** Any exceptions to the bid specification must be stated in the bid.
4. **FREIGHT:** The price submitted must be inclusive of all freight, shipping, delivery, and installation charges.
5. **DEFAULT:** All commodities furnished will be subject to inspection and acceptance by the City after delivery. Default in promised delivery or failure to meet specifications authorizes the City to cancel award.
6. **ETHICS:** "It shall be a breach of ethical standards for a person to be retained, or to retain a person, to solicit or secure a City contract upon agreement of understanding for a commission, percentage, brokerage, or contingent fee, except for the retention of bona fide employees or bona fide established commercial selling agencies maintained by the contractor for the purpose of securing business."
