# CITY OF SPARTA Request for Bids Paving of City-Identified Existing City Streets June 30, 2022 at 1:30 pm

The City of Sparta will receive bids for paving until 1:30 p.m. on Wednesday June 30<sup>th</sup>, 2022 at which time the bids will be publicly opened and read aloud. The bids will be to establish Calendar Year 2022 pricing to overlay various city-identified existing city streets with 1-1/2" 411-D and 411-E Asphaltic Concrete Surface Hot Mix laid in place and to establish per square yard pricing for Cold Planing of Bituminous Pavement at 1-1/2" depth.

Bids are to be addressed to the City Administrator and delivered to Sparta City Hall, 6 Liberty Square, Sparta, TN 38583 and to be received before the bid opening time.

Bids shall be identified on the exterior of the sealed envelope with all the information required by law including the name of the project ("Street Paving bid") and the bidder's name, address, and license number. No bids may be withdrawn for thirty (30) days from the bid opening date.

By virtue of bidding, the bidders guarantee the prices quoted in the bid will remain firm for the duration of the calendar year 2022.

The intended purpose of this call for bids is to establish per ton pricing to overlay city-identified existing city streets with 1-1/2" 411-D and 411-E Asphaltic Concrete Surface Hot Mix laid in place. It is also intended to establish pricing per square yard for Cold Planing of Bituminous Pavement (1-1/2)".

Supplier of Hot-Mix will furnish, haul, place, and compact to meet all Tennessee Department standard specifications and test reports. Supplier will furnish traffic control, all construction signs, and portable signs in compliance with the MUTCD (Manual on Uniform Traffic Devices) on all projects. Supplier must assign adequate personnel and equipment for job projects.

A minimum asphalt cement content will be required for the following mixes: 411-D-5.5% and 411-E-5.3%.

Mix designs approved by the Tennessee Department of Transportation must be submitted and properly signed within two (2) working days prior to the start of a paving project.

Supplier must use all virgin materials in mix designs.

Supplier must provide certification of Liability Insurance upon notification of being the successful bidder.

Paving projects and tonnages will vary city-wide.

Supplier shall guarantee materials and workmanship against defects arising from faulty materials or workmanship for a period of two (2) years. Sparta's Public Works Director or his designee will have the discretion as to determine the final acceptance of all work performed by the supplier. Guarantee will apply to in-place plant mix asphalt only.

In case the supplier cannot furnish Hot-Mix depending on the one requested, the supplier has the option to substitute a grade of Hot-Mix equal to or better at no additional cost to the City of Sparta. If the supplier does not want to substitute, the City of Sparta Board of Mayor and Aldermen reserves the right to obtain the Hot-Mix from the vendor who had the next lowest bid.

Sparta's Public Works Director or his designee will supervise all work. He will decide all questions which may arise as to the quality and acceptability of the materials furnished and work performed. In all of these matters, the decision of the Public Works Director or his designee will be final and binding. The Public Works Director or his designee will have the authority to suspend the work, wholly or in part, for such periods as he may deem necessary, due to unsuitable weather, or for any other conditions considered unsuitable for the execution of the work, or as deemed to be in the public interest.

In case of tie bids, the Sparta Board of Mayor and Aldermen reserves the right to negotiate with bidders, or reject any and all bids. The right is reserved as the interest of the City of Sparta, Tennessee may require to reject any and all bids received.
