The City of Sparta Tennessee will receive sealed bids for Sewer Upgrades for **Burley, Love, Riverview, Wagoner Streets and Hwy 111** until 2:00 p.m. on Tuesday, September 20th, 2022. At that time the bids will be publicly opened and read aloud. Late bids will not be considered.

Bids are to be delivered to Sparta City Hall at 6 Liberty Square, PO Box 30 Sparta, TN 38583. **Bid must be clearly marked "Bid for Sewer Project" on the outside of a sealed envelope.** All bids must be signed.

No bid may be withdrawn for thirty (30) days from the date of the bid opening. Purchase orders will be issued only after approved by the Sparta Board of Mayor and Aldermen.

The City of Sparta reserves the right to reject any or all bids, to waive any irregularities in a bid. The City of Sparta reserves the right to accept any part, or all of a bid, or to accept that bid, (or bids) which in the judgment of the Board of Mayor and Alderman of the City of Sparta is in the best interest of the City. The purchaser also reserves the right to require a bidder to submit evidence of qualifications as may be deemed necessary by the City Administrator.

***REQUIREMENTS FOR BIDDERS***

1. Replace approximately 3,195 ft of 8 inch by pipe bursting.
2. An additional 160 ft of 8 inch SDR26 PVC or greater and 3 manholes to be replaced with extra crushed stone under base
3. Pre-camera all lines to locate services.
4. Service lines should be 6 inch schedule SRD26 PVC or greater. All services are required to have a cleanout box with a CI lid with the word "SEWER" ON TOP. All boxes shall be traffic rated and provided by the contractor.
5. Manholes casting will be replaced and new 26" and manholes not replaced shall be cement coated with inverts grouted.
6. Contractor shall be responsible for all traffic control.
7. All line connections to existing clay or plastic must use Max-Adapters, no Ferncos.
8. All crushed stone shall be the responsibility of the Contractor.
9. A manhole boot is required whenever a manhole is to be cored.
10. City of Sparta personnel will inspect all construction for quality control.
11. All debris shall be disposed of at 545 E. Bockman Way at the designated location behind the Public Works building.
12. If Bypass Pumping is required, the contractor shall be responsible.
13. All lines require pressure testing
14. All new manholes require vacuum testing.

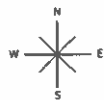

### Sewer - Burley St

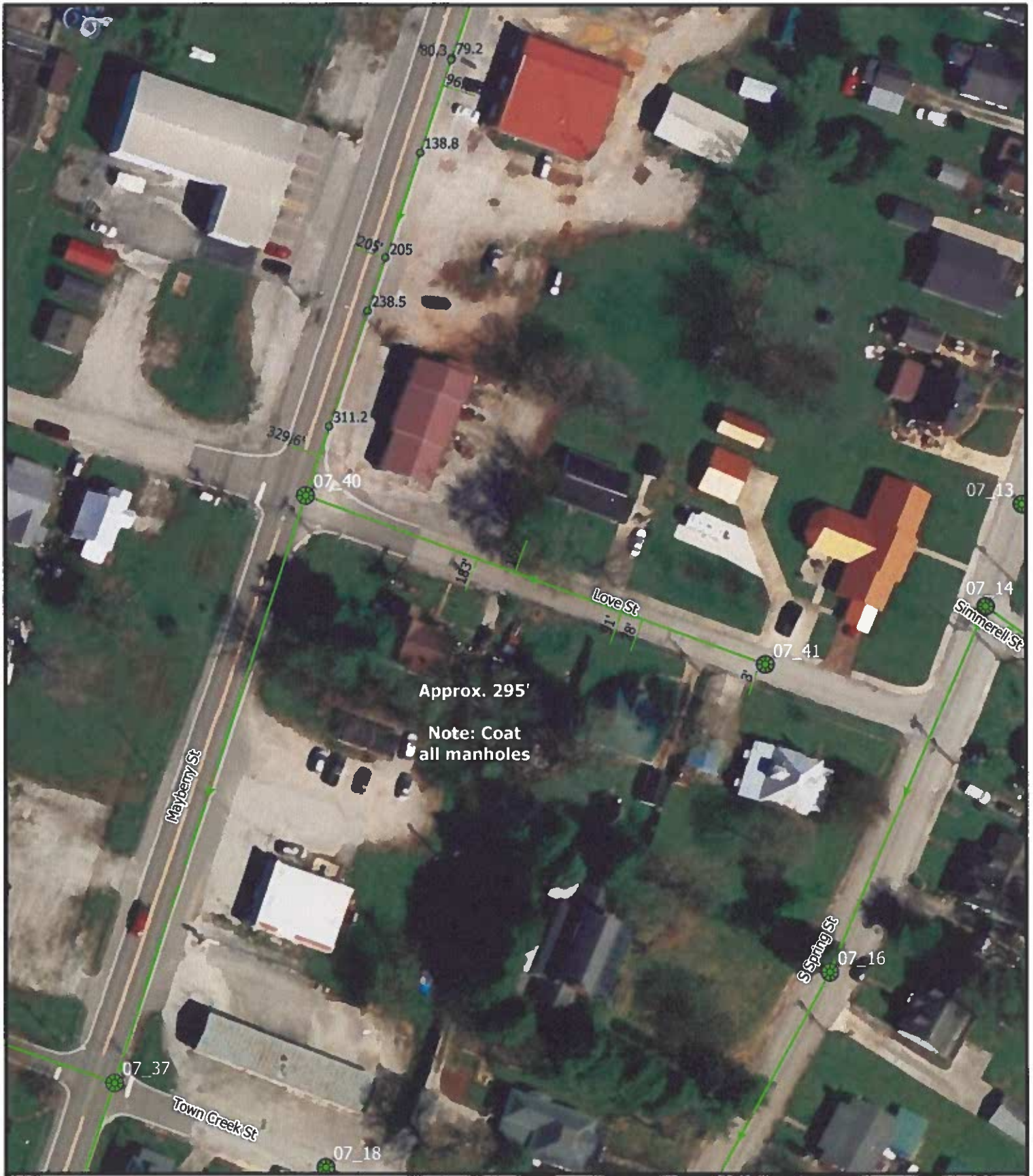

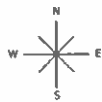

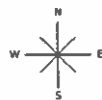

### Sewer - Riverview Dr

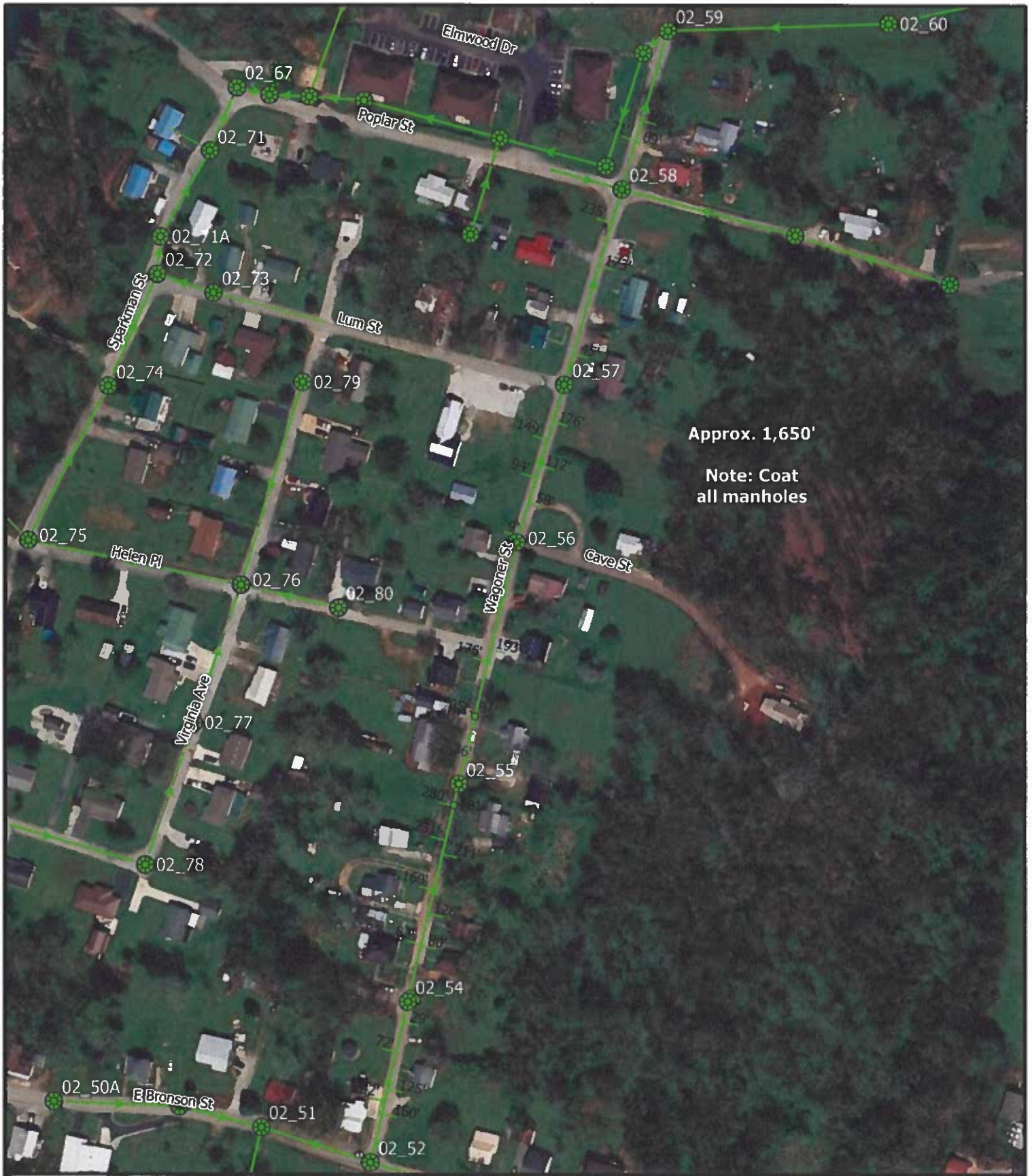

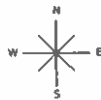

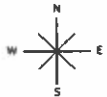
- Replace approximately 180' of pipe with 8" SDR26.
