Bids must be enclosed in a sealed envelope and must be marked "**Commercial Solid Waste Containers, 11/9/23**" on the front of the envelope.. **All bids must be signed.**

No bid may be withdrawn for thirty (30) days from the date of the opening. Purchase orders will be issued only after approved by the Sparta Board of Mayor and Aldermen.

**SPECIFICATIONS**

Containers shall meet the following minimum specifications:

- plastic lids installed on each container
- front loading configuration
- Min. 10 ga. hot rolled steel bottoms
- Min. 12 ga. sides, backs, and fronts
- backs and fronts reinforced with 4" pressed channel and 2 "V" crimps
- 100 % weld inside with skip weld outside
- 1 1/2" drain pipe
- Min. 7 ga. hot rolled steel 1 3/4" x 5" formed channel
- sleeves of min. 7 ga. pressed steel size 4" x 10" x 34" with six min. 7 ga. gussets
- Min. 10 ga., 18" x 6" x 4" reinforced bumper plates
- 100% zinc chromate primer paint outside, undercoat inside bottom and 6" up on each side
- 100% finished with industrial enamel on inside and outside
- color standard dark green
- doors must be of the sliding type 14 ga. pressed steel ***with hasps for locks included***
- each container should be identified with a unique manufacturers serial number
- hinge system adapted for convenient maintenance and replacement of plastic lids
