The grant is for \$15,000 and is a 50/50 match grant. The total project is expected to cost approximately \$29,000.

Ross Fann, Public Works Director, gave progress reports on the following projects: Taco Metals Sewer, 2006 CDBG, and Hampton's Crossroad Sewer Expansion.
