Instructions to bidders:

In order to provide an accurate bid, vendors are encouraged to contact Sparta Public Works Director, Dillard Quick at 931-212-7231 or YMCA Director, Kyle Goff at 931-836-3330, to schedule a time to inspect the site where the generator unit is to be installed.

Generator unit is NEW Natural Gas, 60 kW Generator and a NEW 400 Amp Automatic Transfer Switch that is a 3 phase, 120/240 volt. The city will be responsible for providing mount pad and trenching the ditch for the Conduit, and acquiring necessary permit(s) in order to perform the work and installation of new unit.

Areas of Priority for Generator to Operate:

- All Lights
- 15-ton Trane Unit Supplying Kidzone / Back hallways
- Welcome Center Outlets — computers and cooler
- Office Outlets -- computers, camera, Wi-Fi and microwave
- Refrigerator in Concession Stand
- Deep Freezer in Concession Stand
- Walk-in Freezer (back of building)
- Kidzone outlets -- refrigerator and tv
- Coffee area outlets -- tv, microwave and coffee maker

Bidders must include a time of work commencement from the receipt of a written purchase order must be specified in the bid. No bid may be withdrawn for thirty (30) days from the date of the bid opening. Purchase orders will be issued only after approved by the Sparta Board of Mayor and Aldermen.
