Instructions to bidders:

In order to provide an accurate proposal, vendors are encouraged to contact Sparta Public Works Director Dillard Quick to schedule a time to inspect the site where the unit is to be installed.

Unit must be NEW 3 phase, 15-ton HVAC unit, Electrical rating- 208-230, forced air furnace w/cooling, Heat output must be comparable to 350,000 BTU. Completed job must include an "Emerson" digital Wi-Fi thermostat in order to be compatible with existing equipment. Bidder will also be responsible for removing existing unit, and providing mount pad, duct work, wiring, and acquiring necessary permit(s) in order to perform the work and installation of new unit.

Existing unit will be retained by City of Sparta and shall be placed on trailer provided at the jobsite by the City.

A guaranteed delivery time from the receipt of a written purchase order must be specified in the bid. No bid may be withdrawn for thirty (30) days from the date of the bid opening. Purchase orders will be issued only after approved by the Sparta Board of Mayor and Aldermen.
